The executive order does not mean that any non-compete or non-solicitation for similar type provisions are valid. It is an indication to the federal agencies to investigate the unfair use of these types of agreements or restrictive covenants and particularly the effect that they may have on worker's mobility. The executive order is more likely to affect companies that are larger in scale that have a national workforce and that use non-compete agreements unnecessarily to keep employees from being able to have options to leave the company.

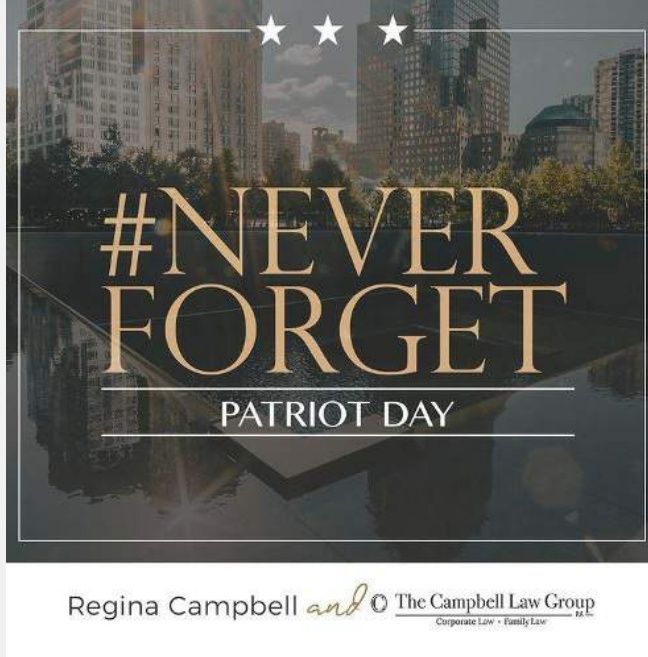
